#### Reports & Correspondence from Officers:

- Chairman Gile received a new revision of the State Municipal Agreement (SMA) in regard to the Main St Bridge Project
- Chairman Gile received a solicitation from the Towns Advocacy Council

#### Agenda items:

- a) Dean Prindle Property Dean Prindle's sister Laurie provided an update on the progress of her brother's property. Electric is back on, Furnace is working, repairs are being made. Dogs will be vaccinated and registered. Outside metal scrap will be collected. Town Board agreed to continue monitoring improvements. Laurie will attend the January 14<sup>th</sup> meeting to provide more updates.
- b) Veteran's Memorial Jan Elfring, President of the Ladies Auxiliary asked the board for permission to pursue adding a Memorial stone at the Mentor Veteran's Park. She also asked if the auxiliary could refurbish the two benches in the park. She estimates the memorial stone to cost about \$1500 \$2000 and would be funded through donations. The board approved for Jan to move forward.

  - d. Once the new fire station is built the current stations in Alma Center & Merrillan will be repurposed. Leaving only the new station and Mentor.
  - e. A new fire district board has been formed'
  - f. All board members and secondary contacts are listed on the town's website.
